

## TheraSpa™ Hot & Cold Therapy

### HERBAL WRAP FOR NECK & SHOULDERS

#### HEAT

1. Place wrap in microwave, allow turn table to rotate freely
2. Microwave 1 minute
3. Depending on desired warmth, microwave in additional 30 second increments as needed
4. Check temperature
5. Gently shift herbs from side to side
6. Apply/wear

#### CHILL

1. Seal in plastic bag
2. Place in freezer for 1-2 hours or longer
3. Shift herbs side to side
4. Apply/wear

#### CARE AND MAINTENANCE

- Wipe with damp cloth
- Air dry
- Do not wash, wet, or submerge herb pack
- Store in air tight bag
- Place in cool, dry area

#### CAUTION

- Learn your microwave settings
- Check temperature before use
- Do not overheat
- For external use only
- Ask doctor if you have pre-existing conditions
- Do not wash, wet or submerge herb pack

# ONE (1) YEAR LIMITED WARRANTY
